



## RESPONSIBILITY AND WAIVER OF LIABILITY AGREEMENT

I understand and acknowledge the danger associated with the discharge of firearms and the shooting sports conducted on the LunaRita Outfitters Training Preserve property located at 2408 Highway 82, Patagonia, AZ.

As consideration for and as a condition for use of property, facilities and services at the LRO Training Preserve (LROP) and for other good and valuable consideration, (1) I hereby, ASSUME THE RISK OF INJURY AND LOSS associated with my presence on, and use of the LROP's property; (2) I, and for my heirs, next of kin, and assigns, HEREBY RELEASE, DISCHARGE, AND GIVE UP, ANY AND ALL CLAIMS AGAINST THE LROP and/or ITS OWNERS, DIRECTORS, EMPLOYEES, AGENTS, and/or ASSIGNS FOR INJURY, DEATH OR PROPERTY DAMAGE that arises out of the negligent act(s) or omission(s) of LRO and/or its owners, directors, employees, agents and/or assigns, as it relates to my use of its property, the condition of its property, or activities being conducted on its property regardless of whether I am participating in those activities, and I hereby agree and covenant on behalf of myself, my heirs, next of kin, and assigns, not to sue LRO, its owners, directors, employees, agents, and/or assigns for injury, death, or property damage; and (3) I AGREE TO INDEMNIFY, AND HOLD HARMLESS LRO AND ITS OWNERS, DIRECTORS, EMPLOYEES, AGENTS and/or ASSIGNS FROM SUCH CLAIMS AND PROMISE NOT TO COMMENCE LEGAL ACTION FOR SUCH CLAIMS. The foregoing is to be construed broadly to provide a waiver and release of claims to the maximum extent allowable by law, and such waiver and indemnifications shall be perpetual in duration.

I am solely responsible for injury or damage to property caused by my negligence or fault or the negligence or fault of the minor children for whom I am the parent or legal guardian of while we are on LRO's property. I further represent that neither I nor any minor child participating in shooting activities hereby are legally prohibited from possessing or using any of the firearms that I or they will bring onto LRO's property.

I acknowledge the right of the LRO's management and employees to immediately terminate my participation in activities for my failure or the failure of my guests, or minor children or minors for whom I am the legal guardian to fully comply with the LunaRita Outfitters Training Preserve Safety Rules ( LROP Rules) or for any other reason at any time. I further understand and agree that my noncompliance with the LRO Rules and the directives of its management may result in the revocation of my shooting privileges.

I have received, a copy of the LROP Rules, and I have read, understood, and agree to abide by the LROP Rules as currently written and as may be amended from time-to-time. I certify that I have read the foregoing, that I fully understand it, and that I have signed it of my own free will. I understand that by signing below, I am entering into a contract with LRO by which I am releasing it from liability and that I am giving up certain rights of my minor child(ren) or ward(s) to bring certain claims as a condition of and as consideration for use of the property, facilities and services at LRO and the rights and privileges associated therewith.

## LunaRita Outfitters Training Preserve RULES

LunaRita Outfitters Training Preserve (LROP) is a safe, friendly, and respectful place for members, non-members, and visitors to. All members, non-members, staff, guests, and visitors are expected to conduct themselves at all times in a manner that:

- Creates an environment that is reflective of personal integrity, respect, and safety for the activities involved. These qualities must be reflected on the property. Is vigilant about their safety, the safety of their dogs, and the safety of others. Safety is everyone's responsibility. Anyone who observes an unsafe behavior, unsafe condition, or potential safety hazard, is encouraged to report such to the management.

### GENERAL RULES

1. You are responsible for your safety and the safety of your dogs. You and your guests must behave in a safe and responsible manner at all times.
2. Alcohol, illegal drugs, prescription drugs that may impair motor skills or cognitive abilities, and shooting DO NOT mix. No one is allowed to shoot who has previously consumed alcohol, illegal drugs, or a prescription drug that impairs motor skills or cognitive abilities on the day of shooting or who appears to be under the influence of alcohol or such drugs.
3. All shooters and observers are encouraged to, but not required to, wear hearing and eye protection while engaged in shooting activities.
4. No shooting in designated (No Shoot) zones as posted.
5. LRO's owner lives on this property. No shooting toward any facilities or buildings
6. No pursuit of game birds released off the fenced property
7. Members or non-members utilizing any equipment supplied are responsible for its safe return to storage areas provided. Any equipment damaged during use is the responsibility of the member or non-member as applicable.
8. Report any damage to property or equipment immediately to LRO or an employee.
9. Pick up all shell casings and any trash
10. Utilize mowed paths whenever possible. This is to preserve grasses and cover for continued usage of members
11. Comply with all laws regarding firearms discharge. Specifically, no shooting across a designated road.
12. You are authorized by the owner to shoot within 1/4 mile of the occupied buildings. This is stated to ensure compliance with state laws. You have the owner's written permission to discharge a firearm.
13. At the end of activities, please report number of game birds released and the number located or taken on the report link provided. This is a state requirement for reporting and licensing of the preserve.
14. If LRO homing pigeons are utilized, we document the number of the birds band. If you lose, shoot, or your dog injures or kills a homing pigeon, you are responsible for the cost of the bird. The price per homing pigeons is 50 dollars per bird.
15. Gamebird pricing is variable based on purchase price from suppliers. Pricing will be up to date on the website and invoiced accordingly.
